



ACT 48 Credits for PA ISTE 2010 Attendees

For those Pennsylvania educators who need Act 48 credits, the Pennsylvania Association of Educational Communications and Technology (**PAECT**) is offering Act 48 credits to all attending ISTE 2010.

To obtain your Act 48 credits, you must be registered for the conference and obtain an Act 48 form from the **ISTE 2010 Information Booth** prior to the first session each day. Then, after attending your sessions and completing the attendance forms, return all forms to the **ISTE 2010 Information Booth**, before 3pm on Wednesday, June 30.

Whether you are attending the conference for **ONLY ONE DAY** or **ALL DAYS**, you will need to submit your Act 48 form **AFTER** your **LAST SESSION** and before the end of the conference.

To receive your credits you must attend a minimum of 3 hours of conference or workshop sessions.

To receive Pennsylvania Act 48 credits for the Conference General Sessions, you must:

- Obtain an ISTE 2010 Act 48 form for each day from the **Information Booth**
- Attend your sessions
- Complete the forms
- Obtain, complete and sign an ISTE 2010 Conference Attendance form from the **Information Booth**
- Before the end of the conference, return all the forms to the **Information Booth**

To receive Pennsylvania Act 48 credits for your Workshop and/or Pre-Conference Session(s), you must:

- Obtain an Act 48 Workshop Form for each day from the **Information Booth**.
- Complete the form
- Obtain a signed ISTE Workshop Attendance form from the workshop Presider.
- Submit both forms after your session(s) to the **NECC Information Booth** during the published registration open hours.
